- IV. Head of School report Alicia Weatherly
 - a. Enrollment 98
 - b. Brittany is condensing our enrollment packet
 - Boys basketball ended on March 4 with a 4-2 record; Coach Gray would like to host skills camps for both boys and girls
 - d. Spring Break is next week
 - e. Kindergarten Roundup is April 12, staff incentive to share the info
 - f. Literary Night is April 24, including activities related to books, drawings for free book sets
